VII. Treasurer's Report

- There are 52 owners, or 8%, who are delinquent with their payments.
- Our owners' assessment has remained the same for over 12 years; however with increased costs, the Board voted to adopt a slightly higher budget reflecting an increase of \$10.512.
- 39 owners have outstanding balances less than \$50 and should have received notices/ invoices from ACS West, Inc.
- Recent changes to Virginia law make enforcing and collecting from delinquent accounts more complex.
- We must plan and keep adequate funds in our reserve account to effectively plan for ongoing maintenance or replacement.
